Among the topical issues raised in the book of the first President Islam Karimov "Uzbekistan on the threshold of independence" is the creation of favorable conditions for the participation of women in public production and management in order to properly guarantee the protection of the socio-political rights of women and their prestige. It is noted that the protection of maternal and child health, education and culture of the population should be ensured in all socio-economic and ideological aspects. Every woman living in Uzbekistan today is truly happy. In the end, his rights and freedoms are enshrined in law, and his goals are raised to the level of the goals of society. The Constitution of the Republic of Uzbekistan, dozens of laws, about eighty decrees and resolutions, state programs serve as the legal basis for increasing the social and political activity of women, strengthening their status in the family and society, protecting the family, motherhood and childhood.

In 1996, the Cabinet of Ministers adopted the Concept for the Improvement of the Status of Women in the Republic of Uzbekistan. The submission of the National Report on the Implementation of the Convention on the Elimination of All Forms of Discrimination against Girls serves to realize the constitutional rights of women.

The wise policy pursued in the country today makes the dreams of our sisters come true. In the stories of our mothers and grandmothers, we often hear that in the former Soviet Union, women lived within four walls, and that mothers did not spare themselves for the "plan," kissing their children in the poisonous cotton fields. No matter how hard it was, no matter how much oppression our women were subjected to, endurance, perseverance, self-sacrifice, hard work, in short, tolerance made them heroes of today's healing days, a symbol of loyalty and tenderness. ... Fortunately, the current era is truly becoming a symbol of a truly free life for women. Their rights are protected, the most necessary and necessary conditions are created for their peaceful life.

Achieving social equality is a complex and lengthy process that depends on the level of social development, economic opportunities, ideological programs, cultural and spiritual potential of the country. Creating opportunities for involving women in various spheres of life and work, developing and implementing long-term state policy in this area, aimed at improving the social status of women in accordance with the current economic conditions, will strengthen their place in the world. society. Our country pays great attention to this. And this is not accidental, because in Uzbekistan women make up a large number of strata of society, have their own mental and demographic characteristics, different functions and a certain social status. Harnessing the enormous potential of women and empowering women to achieve their goals will contribute to the rapid economic, social and political growth and development of the country. Discussion of the preparation of active women with the appropriate skills and abilities for leadership positions, the full support of women entrepreneurs, especially the development of family businesses, will be a leading help in this direction. Focusing on measures to reduce crime against women will also help them escape crime scenes and regain their place in society.

Women who took to the streets of crime did not stand aside. On the occasion of the twenty-fourth anniversary of the adoption of the Constitution of the Republic of Uzbekistan, at the suggestion of the President of the Republic of Uzbekistan, the Act on the Application of Amnesty was adopted in accordance with the principles of humanity. adopted unanimously. According to the law approved by the senators, women who have committed crimes can be pardoned under an amnesty. Last year, President of the Republic of Uzbekistan Shavkat Mirziyoyev pardoned one woman on the occasion of the 28th anniversary of the Constitution.On May 21, 2020, 258 people were returned to their homes from penitentiary institutions. In addition, last year, two Uzbek women serving sentences in correctional institutions of the Republic of Turkmenistan were released under an amnesty and returned to our country. All this is done so that women can learn from their mistakes, properly spend the rest of their lives and have a place in society. We hope that women who have committed offenses will seize this opportunity. There is a saying among the people: it is better to prevent a disease than to cure. "I mean, it's more important to focus on them before they commit the crime, rather than after they commit it. It would be more profitable for society to focus on the problem of concern to them before they are forced to commit a crime, to the extent that this can replace amnesty

In Uzbekistan, too, special attention is paid to women who have fallen into the trap of religious fanaticism and who have joined extremist groups abroad. This is evidenced by the return of 156 Uzbeks (48 women and 106 children) from Syria on a special flight on May 30, 2019 as part of the

humanitarian operation "Mercy" ("Mehr"). President Shavkat Mirziyoyev said the government should provide medical, psychological, material and spiritual assistance to people who "left for another country as a result of deception and went through a difficult period of life" so that they could return to a peaceful life and adapt to society. It was noted that it is necessary to create the necessary conditions for participation in educational and social programs, take measures to provide housing and employment and provide them with assistance. Three women who joined the Islamic State (IS) extremist group were pardoned in August and four in December. Unfortunately, it was not possible to return all the women and children detained in the camp. Tanzila Norbaeva, chair of the Women's Committee of Uzbekistan, said that the operation to remove women and children from the conflict zones in the Middle East will not end there and the practice of their return will continue. The saddest thing is that among them there are women who call Uzbekistan "a state of unbelief" and prefer to stay in these conflict zones. It is heartbreaking to see how these women, who have become real mangroves, destroy the future of themselves and their children with their own hands. It is not hard to see why such blind women are mistakenly found themselves in such a predicament. The reason for all this is the neglect of women. If attention was paid to the timely spirituality, education and advancement of women in the country who preferred this bloody land to their peaceful homeland, they would not be so devoted to fanaticism, and their children would become fathers. are they forced to pay for their future because of the mistake of their mother? ... If we begin to see women not as ordinary weak, but as educators of young people who are the future of our country, we will contribute to the bright future of our country. country. Let us not be indifferent to the pain, conditions and life of women around us. Let's not just wait for the government to help them, but just pay attention to them as ordinary people. All the mistakes they make are due to our negligence. We must not forget that in a country where a woman is considered sacred, special attention should be paid to her rights and desires.

When it comes to increasing the social activity of women with disabilities, it is important to provide psychological support and support when working with this category of women. At the same time, attention should be paid to improving the social conditions for them and providing them with employment opportunities.
